Priorities

 Significant agreement on the five priorities

Mandate

- The majority of the Board is open to at least looking at options outside of the current mandate (yes & possibly 70%)
- The majority of the Board expressed interest in looking at "innovative financial arrangements" (yes & possibly 70%)

CSRHD role

 There is strong interest in the advocacy role of the Board – some expressed a keen interest in formalizing & developing a plan for advocacy.

Key takeaways

Ways to work with IH

- Concerns were expressed regarding erosion and loss of services previously committed to by IH
- Concerns were expressed about the challenges of working with a large bureaucracy like IH & the power imbalance
- Concerns expressed about the disconnect between communities and Island Health

 would like to see better community input
- Interest expressed in partnerships with not for profit organizations & IH

Island Health Innovative Funding Options

Community lease consolidation for community health and service hubs

Long term care

Community lease consolidation for community health and service hubs

- Bring together several community health services
- integrated community, health and even housing supports have proven to have positive effects on populations served through an integrated and holistic approach
- need is for 15,000 to 30,000 square feet
- Order of magnitude costs for options (excluding land value):
 - 15,000 SF of leased space: \$5.25M
 - 30,000 SF of leased space: \$10.5M
 - 15,000 SF of built space: \$10.5M
 - 30,000 SF of built space: \$21M



Campbell River Long Term Care

- Island Health is currently completing a business plan for the development of a 150 bed LTC facility on the Campbell River Hospital Campus.
 - North Island has 10% fewer LTC beds per 1,000 population than the Island average (56.0 vs 63.5)
 - Campbell River has LTC demand per 1,000 population 35% higher than the Island average-highest of any community on the Island
 - Last year, the percent of patients in the North Island Hospitals that could have been cared for in LTC ranged from 17% to 33%.
 - On the low end, there were ~51 hospital beds (17% of existing hospital capacity) that could have been freed up through investment in the LTC and on the high end ~77 beds (33% of hospital capacity) could have been freed up.
- Order of magnitude estimates indicate a cost of approximately \$60M
- Potential 40% cost sharing or Transitional Care and/or Restorative health (acute care)

Rural Health Clinics

CSRHD provides unconditional grant funding of \$5,000 to each of six rural health centres across the CS region as follows:

- Cortes Health Centre
- Gold River Health Clinic
- Kyuquot Health Centre
- Sayward Health Centre
- Tahsis Health Centre
- Zeballos Health Centre

Separately, capital improvement requests are submitted through the CSRHD's \$1.85 million allocation to Island Health. Medical Clinic

Recent examples of capital requests:

- 2019 Kyuquot for dock repairs
- 2018 Zeballos Health Centre for a backup generator
- 2016 Gold River Health Centre for an x-ray machine with PACs capability and again in 2017 for a wheelchair accessible main entrance door

Potential to partner with Island Health to provide additional funding to support these rural health clinics - annual grants have not increased since 2016.

Examples from other Hospital Districts Capital Region Hospital District (CRHD)

Powell River Hospital District (PRHD)



Willingdon Creek Village (PRHD)

- 102 bed Complex Care home with all private rooms with en suite shower.
- Total cost \$25 million
- PRHD contribution \$4 million from reserves \$20 million borrowed
- VCH contributes 64% of \$26 million
- Annual debt approximately \$1.5 million (\$1.1 million from VCH & PRHD \$400,000
- 4% goes to reserves annually for asset management/maintenance
- VCH was responsible for design, tendering and contruction
- VCH is fully responsible for operations

Summit at Quadra Village

- 320 unit complex residential and dementia care facility.
- \$86 million total cost
- The land and building are owned by the CRHD.
- Island Health operates the facility (provides residential care services)
- Through a financing agreement Island Health will lease the building for 25 years and CRHD will recover its costs this way.
